ASA CIRCULAR 45 OF 2020 - ORDERING 2021 ASA LICENSES

Dear ASA Members

ASA will soon be ordering ASA Licenses for the 2021 athletics season and request provinces to order ASA Licenses **no later than 2 October 2020**. In ordering licenses, please keep in mind that all athletes participating in ASA National, Provincial and club listed events, must be licensed athletes.

Also keep in mind that all Primary School and High School events at district and provincial level must be listed on the Provincial Fixtures List. Effectively, this means that all school athletes participating in a district and provincial championships, must be in possession of a junior license before the athlete can be entered for participation.

Order procedure: Please order licenses needed for the 1st quarter of 2021. As ASA cover the delivery cost; minimum re-orders of licenses will be 50 permanent licenses and 100 temporary licenses from the 2nd order onwards. For all orders, a delivery period of 2 weeks is required.

Payment procedure: Payment for the 1st license order must take place by 28 February 2020 latest as per ASA Constitution stipulation. To avoid late deliveries, an upfront payment will be required for any order, other than the 1st order. A penalty of 10% will be charged on any late payments of licenses.
